## Course Rules and Important Notes:

- I will pay attention to my instructor at all times.
- I will not drink alcohol or take drugs during the course. (Don't drink and drive! Four-wheel driving requires every bit of skill and judgment you can command. Drugs and alcohol can lead you and your companions into a dangerous situation. If you are on medication which carries a vehicle/machinery operation warning, you will not be able to drive during this course.)
- I have vehicle insurance and medical insurance for everyone in the vehicle. I will arrive prepared to show my instructor copies of my insurance papers.
- I will buckle up during the course. (Seat belts are MANDATORY! They help keep you in place on rough terrain. Accidents can happen, even to the best four-wheel drivers.)
- I will comply with all posted signs on the road and trail.
- I will respect and be considerate of other users so that all can enjoy a quality experience in the outdoors.
- I will maintain a reasonable distance between my vehicle and my fellow course participants. ("Tailgating" can lead to serious injury to you, your vehicle, and others.)
- During the course I will avoid sensitive wildlife habitat - e.g. wetlands, streams, meadows, fields. (Crashing through undergrowth, or across meadows can destroy nesting sites and other sensitive habitat. Stay on designated trails and roads.)
- I will respect all wildlife during the course. I will be sensitive to their life-sustaining needs by keeping my distance.
- I will ride in the middle of the trail to minimize widening it. Unless safety is an issue, I will resist the urge to ride "high" on banking corners.
- When driving during the course, I will yield to horses, hikers, and bikers. I will stop and let them pass me, I will not drive around them.
- I will yield the right of way to drivers on the uphill grade or those overtaking me.
- I will arrive at the designated meeting place on time. Further, I will arrive with my vehicle ready to drive immediately upon arrival - full of fuel and with all items needed for the course in my vehicle.
- I realize that I need the following items in my vehicle during the course and that I will supply these items:
  - Drinking water for an entire day on the trail and lunch for all participants.
  - Seat belts, roll bar, spare tire
  - CB radio (if you do not have a CB, contact Bob for options)
  - Trash bag
  - Folding chairs (to sit during demonstrations, lunch, etc.)
- I realize that due to the expeditionary nature of this tour, the exact details, route and itinerary may change. Every effort is made to conduct the trips exactly as presented, but that is not guaranteed.
- I give Blue Sky Adventures, Inc. my permission to use photos of me, my passengers and my vehicle in promotional material.
